ACTION ITEMS

1. Discussion and action to approve or deny the appeal for a student seeking early admission to 5K. Motion to discuss and approve or deny the appeal for a student seeking early admission to 5K (Larson/S Maurer) Chad Schraufnagel gave an update to the board on actions taken by the district since the last meeting. Referred to Kelley Berlin, School Psychologist and email that he sent to the board. Chad reminded the board that it is bad precedent to go against policy. P Maurer stated that policy 421 has been revised and the grid has been removed, and has concerns that the board is using a changed policy as the reason for declining. Monique Henry reminded the board that the grid was removed to give staff flexibility when a case is extreme, however there is nothing extreme in this case. Parents commented that screening does not reflect the child's abilities and the child has already completed the 4K curriculum at ULS. Al Larson would like the board to defer to teachers and Psychologist. Jhawn Nwman is putting heavy weight on policy and recommendation.

2. Discussion and action to approve Administrator to hire 7th Grade Teacher for the 2022-2023 school term

Received 1 applicant but the resume isn't strong enough to interview. Matel and Voelker have created a schedule for students with 2 teachers and no new hire. If a candidate is found, a limited contract is advised.
