Special Education Aide rate of pay

Chad Schraufnagel spoke to the board about the rate of pay for Special Education aides. Stated that areawide Districts are increasing their rate and some are giving hiring bonuses. Recommends the board approve raising the rate to \$18/hour and to discuss it in the next committee meeting.

Update on SiteogiQ meeting

Chad Schraufnagel stated that SitelogiQ is a one stop shop for the future referendum. It's their specialty and they are out of WI. The District would pay for services through the referendum. If the referendum does not pass, the District does not pay. Once a contract is signed, if the District doesn't go to referendum, we must pay 0.27/sq ft. Steve Maurer questioned if there was someone the District could call in to help us meet our budget. Chad Schraufnagel responded that the District is consistently doing so, Todd Gray, Baird Model, Baker Tily audit. Monique Henry responded that even if the District could balance the operational budget, there are still huge capital expenditures needed.

Peter Maurer responded that looking at the deficit he doesn't see how we can pay 4.7%. Chad responded that decisions like the Clevertouch boards and boiler were made before he was here. Steve Maurer believes the community will be upset if we go to referendum after giving the top raise. Jhawn Newman would like to address the budget in other areas not in teacher pay. Al Larson questioned why we would be the outlier in the area when we are #1. Vote: 5-0
